## FEE SCALE

This fee scale details fees charged by Premium Visa Solutions Ltd (PVS) for all immigration advice and services that we are registered to provide to our clients. We charge on a fixed fee basis. However, should you wish to withdraw instructions part way through your immigration case we will charge you for all work we have undertaken on your behalf at an hourly rate of £100. Please note that Premium Visa Solutions Ltd is not VAT registered. Therefore, VAT will not be added to the fees outlined below. We accept *British Pounds Sterling (GBP) only.* 

Our fees are calculated taking into consideration all of the circumstances of the case. Primarily we assess our costs on an hourly rate with reference to the time spent on the matter. We may estimate the likely time the matter will take and quote you a fixed fee.

For matters where it is not possible to quote a fixed fee our time spent is calculated by recording items such as: incoming and outgoing telephone calls, reviewing incoming correspondence, drafting and preparing outgoing correspondence, any personal attendance, research time, and time spent instructing experts. We also assess factors such as the complexity of the case, the urgency of the matter and the amount of documents involved. Fixed fees cover the normal work to be undertaken in:

- Advising you
- Reading your file
- Preparing your case
- Checking your documents
- Corresponding on your behalf
- Updating you with the progress
- Making and receiving telephone calls
- Standard UK Postage/ telephone costs

# DISBURSEMENTS

The estimation of fees given to you does not include disbursements payable to a third party of whatever nature. Disbursements such as Home Office application fees, Immigration Health Surcharge, courier charges, translation and/ or interpreter fees and other expenses should be paid directly to the authorities or relevant service providers. We cannot guarantee the total amount of expenses that will be involved in any matter, but we will give you our best estimate of likely expenses at the outset. Disbursements in terms of national and international telephone calls made on your behalf or in relation to your matter will be charged to you whereby we will invoice you as we charged by our service provider. International courier services will be charged additionally.

If any unforeseen work becomes necessary, we will be entitled to charge extra fees. We will try at all costs to avoid this situation. However, if deemed necessary, we will advise you accordingly and attempt to agree with you the additional fees to be charged.

#### HOURLY RATES

We will keep you informed of the hourly charging rates of each fee earner working on your case at all times. Our current hourly rate is £100. Hourly rates are reviewed yearly.

### PAYMENTS TO US

We can accept payment by bank transfer or online. We shall send you our invoice with mutually agreed fixed fees before we commence our work. Depends on a complexity of your case we shall send you our additional invoice if your case requires more time.
